

Fee Reimbursement Form Critical Shortage Area Endorsements 2018 - 2019

An educator who passes a licensure assessment in a chronically critical shortage area (listed below) and adds an endorsement to a current Arkansas license may be eligible for a one-time fee reimbursement for all tests required of the endorsement. Reimbursements are processed on an as-received basis and are subject to funding availability.

To be eligible for the assessment fee reimbursement:

- Currently teaching in an Arkansas public or charter school
 Complete all requirements for the endorsement area including coursework if applicable
 Achieve a passing score on the required assessment(s)

To receive assessment fee reimbursement, a test taker must provide the following:

- A completed Critical Shortage Area Endorsement Fee Reimbursement Form
 Proof of payment provided by testing company
 A copy of Official Score Report provided by the testing company showing a passing score on the licensure assessment
- 4. A copy of official or unofficial Arkansas Educator License showing the added endorsement area 5. A completed W-9 Form with name, home address, Social Security Number, signature, and date
