To begin, you will select the district in which you reside. The county and superintendent information will populate based on your selection. If you do not know your current school district, you can contact the Home School Office at 501-682-1874 to obtain this information in order to proceed with the application.



Next, you will choose your start date. If you are unsure of the date, you should choose, click "Help me choose" for additional information:

The school year used for the application will be based off of the start date. If the date entered is before July 1, then the application will be for the previous school year. If the date entered is on or after July 1, the application will be for the next school year. For example, if a start date of February 1, 2012 were chosen, the school year for the application would be for the 2011-2012 school year. If a date of July 1, 2012 were chosen, the school year for the application would be for the 2012-2013 school year.

HOME SCHOOL WAIVER FORM

Arkansas Code Annotated § 6-15-503, as amended by Act 1117 of 1999, requires that parents and guardians who wish to home school their children, sign a waiver acknowledging that the State of Arkansas is not liable for the education of their children during the time the parent or guardian chooses to home school.



You will be sent an email to the address listed on the application notifying you that your notice of intent has been successfully submitted.

Once your application has been reviewed by the Home School Office, you will be notified via email as to when your student(s) is legally registered and enrolled.

NOTE: Be sure to check your junk mail for notification from donotreply@arkansas.gov that your notice of intent has been submitted if you do not immediately receive the email. Be sure to add donotreply@arkansas.gov to your list of safe recipients and identify that it is not junk mail.




NOTE: You will not be able to click to enroll or withdraw a student until **AFTER** the application has been officially approved by ADE.


